This letter is to confirm the City of Hercules's staff recommendations regarding the preferred project alternative for the Hercules Intermodal Transit Center (ITC) as analyzed in the Environmental Impact Report (EIR)/Environmental Impact Statement (EIS). Staff recommends that the City locate the ITC west of Refugio Creek, at the location identified in the Draft EIR as Alternative 1 because the location:

- Has adequate tangent track length (sufficient area for straight track, as required by Union Pacific Railroad (UPRR));
- Is consistent with the Waterfront District Master Plan, which limits the location of a train station to the Bayfront Boulevard Main Street (T5-MS) zone, i.e., blocks E, G, and I, parcels that are all on land west of Refugio Creek; and
- Enjoys active support from nearby residents;

Within Project Alternative 1, there are two different railroad track options. Of these, staff recommends that the City choose Track Option B (as listed in the DEIR), which would realign the existing two mainline tracks to accommodate the station and center island platform, and add a third main track. Staff recommends this alternative track alignment for the following reasons:

- Eliminates the need for two shoofly tracks;
- Simplifies project construction staging needs;
- Shortens overall construction duration;
- Eliminates culvert strengthening and temporary railroad bridge extension;
- Reduces cost of retaining wall through the station area;
- Reduces cost of center platform;
- Reduces overall project cost by an estimated \$500,000;
- Minimizes interruptions and operational impacts to through-traffic and passenger services;

- Minimizes freight-vs-passenger train conflicts;
- Improves on-time train service along the corridor for long-term operations;
- Enjoys active assistance and support from key stakeholders, including the host railroad (UPRR), managing authority (Capitol Corridor Joint Powers Authority), and operating agency (AMTRAK) to obtain timely design review permits.
